# Admission Procedure for Bachelor of Pharmacy:

## 1. Sanctioned Intake:

There shall be 60 sanctioned intake seats available for admission to F. Y. B. Pharm.

#### 2. Reservation:

The reservation shall be provided in accordance with the Hon. Supreme Court judgement dated 31/10/2002 in W.P. (C) No. 317 of 1993 and directives of the state Govt. from time to time.

# 3. Rules of Admission through Centralized Admission Process (CAP):

The Centralised Admission Process (CAP) is a structured and transparent procedure adopted for admission into professional courses in unaided private institutions, as well as in Government, Government-aided, University Departments, and University-managed institutions. This process is governed under sub-section (3) of section 3 of the relevant Act.

## Stages of CAP:

## **Publishing of Information Brochure:**

The Competent Authority releases an official Information Brochure online, which contains all necessary details about the admission process. Candidates must read this brochure carefully.

# Filling Online Application Form:

Candidates are required to fill an online application form within the notified schedule to participate in CAP.

# **Uploading Documents:**

Valid and necessary original documents must be scanned and uploaded during the application process.

# Seat Matrix Display:

The category-wise seat distribution (Seat Matrix) for each CAP round is displayed online for candidate reference.

# **Option Form Submission:**

Candidates submit their preferences of courses and institutions by filling and confirming an online option form. A candidate can select between 1 to 300 options. Once confirmed, these choices are used for seat allotment.

## **Provisional Allotment:**

A provisional allotment list for each CAP round is displayed, indicating the course and institute allotted to the candidate.

## **Reporting and Verification:**

Candidates must either visit the Admission Reporting Centre (ARC) or carry out self-verification of uploaded documents online to confirm their seat. Only after this step, the candidate can report to the allotted institute.

## CAP Round I:

Candidates whose first preference is allotted will have their seat automatically frozen. They must complete document verification and pay the seat acceptance fee online. Failure to do so results in forfeiture of the seat. Candidates allotted seats other than their first preference can either freeze the seat or participate in further rounds for better options.

#### CAP Rounds II & III:

Available seats for these rounds are published online. Candidates who participated in earlier rounds can edit their option forms and participate again. Final allotment must be confirmed by reporting to the respective institute.
